AFRDI continues to be recognised as a Registered Service Provider (RSP).

As a RSP, AFRDI is capable of providing scientific or technical expertise and resources to perform research and development on behalf of other companies.

If you are a small to medium-sized company, AFRDI can help you to identify and gain access to expert R&D. Companies that engage an RSP to perform Research or Development can claim an R&D tax offset for eligible expenditure on registered R&D activities even if their total claim is less than the usual expenditure threshold of \$20,000 in an income year. You would need to seek expert tax advice to ascertain if your company and project is eligible.

Please note that the D is often silent in R&D and shouldn't be. Development is also part of the title. If you have a project that may qualify please contact us at bob@furntech.org.au

Draft DR AS/NZS 4610 parts 1, 2, and 3 - Furniture School and Educational has been released by Standards Australia for Public Comment. These Standards were originally published in 1999 and the Industry is looking forward to the publication of the revised Standards.

The commenting period closes on 18 August 2019.
